**CUSTOMS ACT 1901****INTENTION TO REVOKE TARIFF A CONCESSION ORDER**

The Comptroller-General of Customs intends to revoke the Tariff Concession Orders (TCOs) for the goods described in the following TABLE in accordance with s.269SD(1AA) with effect from 20 June 2018.

On 20 June 2018, the Comptroller-General of Customs' delegate formed the belief in respect of each TCO, that if the TCO was not in force on that day, and an application for the TCO was made on that day, the Comptroller-General of Customs would not have made the TCO on the grounds that he believes that the TCOs are considered to be unnecessary.

A TCO is considered unnecessary if the goods covered by that TCO can be imported under another, often more recent, TCO that often covers a broader range of goods.

Importers and customs brokers will not be disadvantaged by the revocation action, as TCOs will continue to apply to the same range of goods. Before attempting to use a TCO, an importer or customs broker should check the list of concessional instruments to ensure that the TCO still exists.

Interested parties who might be affected by the revocation are invited to provide, by close of business Wednesday 18 July 2018, a written submission why the TCOs should not be revoked.
