

MARKET SUMMARY



- Additional LCL depots are now also introducing time slot fees as high as \$17 per bill of lading for cargo collections. These fees which have to be paid at time of or prior to collection are making transport operations increasingly difficult, as well as being a further financial burden on importers.
- Lines on the S.E. Asia to Australia trade-lane continue to restrict booking space for cargo to Sydney and Brisbane due to heavy congestion, a backlog of containers in transhipment ports, and continuing vessel delays.
- Rates ex: China to Australia are being quoted by shipping lines on a 7 day validity basis currently due to the highly volatile market and supply limitations. General market rates are tipped to be as high as USD 6,000 per 40' container in December if the situation continues unabated.
- Importers and exporters with a consolidated revenue of AUD 100 million or more should review their Modern Slavery obligations under the Act and ensure compliance (see the article in this newsletter)

MODERN SLAVERY ACT: IMPACT FOR IMPORTERS & EXPORTERS

n the 1st January 2019 the Modern Slavery Act 2018 (Modern Slavery Act) entered into force. The Act was established by the commonwealth government in order to take on a global leadership role in the battle against modern slavery. The Government states, "There is no place for modern slavery in the Australian community or in the global supply chains of Australian goods and services." Modern slavery is described as situations where people may be exploited by coercion, threats or deception that undermines their freedom.

Examples of modern slavery include:

- Human trafficking
- Slavery
- Servitude
- Forced labour
- Debt bondage
- · Forced marriage, and
- The worst forms of child labour

The United Nations (UN) estimates that under this definition of modern slavery, today there are approximately 40 million victims around the world.

For companies that have an annual consolidated revenue of AUD 100 million

or more, registration and submission of a statement is mandatory. Companies that have a revenue under the threshold may still opt to voluntarily register and submit if they choose to do so. There is a wide range of guidance available for companies that are required to report, much of it provided by the Australian government.

Reporting is usually based on a financial year, and the first reporting period where mandatory submissions were required ended on 30 June 2020. Initially, submissions were required to be made by 31 December 2020, but due to COVID-19 impacts the government has extended the deadline to 31 March 2021. There is no set template for the statements to be made, and companies are left to formulate their own preferred styles.

There are 7 key points that must be addressed by the statements, listed as follows:

- 1. Identify the reporting entity
- 2. Describe the reporting entity's structure, operations and supply chains
- 3. Describe the risks of modern slavery practices in the operations and supply chains of the reporting entity and any entities it owns or controls

- 4. Describe the actions taken by the reporting entity and any entities it owns or controls to assess and address these risks, including due diligence and remediation processes
- 5. Describe how the reporting entity assesses the effectiveness of these actions being taken to assess and address modern slavery risks
- 6. Describe the process of consultation with any entities the reporting entity owns or controls, and
- 7. Provide any other relevant information.
