

MARKET SUMMARY



- Record high freight levels remain in place for cargo on most worldwide trade-lanes. Rates are nudging USD 5,000 per 40' container in a never-seen-before market situation.
- Shipping lines servicing the China-Australia trade-lane have announced a GRI (General Rate Increase) for the 1st December 2020 at a level of USD 300 per 20' and USD 600 per 40'.
- Dumping duties on aluminium extrusions ex: China have been reduced in a move that brings a little bit of relief to importers (see the article on page 9).
- As a result of many lines not accepting bookings into Sydney over the past few months, the number of containers pending rail movement from the alternative ports of Melbourne and Brisbane into Sydney are become seriously backlogged. Daily bookings are at 140% of capacity resulting in delays of up to 13 days for containers to obtain a rail slot.
- Delays at the heavily congested transhipment ports of Singapore and Port Klang are nearing
 weeks as the number of containers pending loading onto vessels builds up.
- The QLD border remains closed to Sydney and Victoria with a review of the situation expected to take place at the end of November with the hope that the restrictions will be lifted in time for Christmas.



ustralian Stevedores are increasing revenue and profit margins, as a result of the highly controversial terminal access charges, in spite of the largest volume drop seen in a decade.

During the financial year ending in June 30, the country's 4 major terminal operators handled 7.57 million TEU. This figure was reportedly 4% lower according to the Container Stevedoring Monitoring Report 2019-20, published recently by the Australian Competition and Consumer Commission (ACCC).

In contrast, the report indicated that the industry revenue increased by 2.8% to \$1.42 billion (AUD), with revenue per lift up by 7.5% and profit margins up by 9.9% which was mainly due to stevedores increasing terminal access charges, the ACCC stipulates.

"Revenue from these, previously called infrastructure charges, rose 51.9% [to \$256.4m] in aggregate for monitored ports compared with 2018-19."

ACCC chair Rod Sims says, "while there may be justification for landside charges, excessive terminal access charges will nullify the benefits of greater competition between stevedores in providing services to shipping lines. However, regulation of

these charges is for state and territory government. Shipping lines contract with a single stevedore for cargo, and that means there is no direct competition in the provision of landside services. This makes these fees, to some extent, a 'take it or leave it' proposition for importers or exporters that have no direct choice of stevedore."

The "staggering" increase in charges since 2017 has left transport operators feeling complaining that they feel "held to ransom" by the brunt of pressure. The ACCC indicated that the stevedores at the 3 largest ports of Melbourne, Sydney and Brisbane have now charged excess of \$100 AUD per full container.

"Not only have charges increased each year, but higher landside revenues are now more than offsetting any fall in quayside revenues from shipping lines," ACCC said, in reference to the greater competition after introducing third terminals in Brisbane, Sydney and Melbourne which resulted in falling revenues from shipping lines for each lift.

Neil Chambers, director of the Container Transport Alliance Australia, said the ACCC "couldn't be any clearer" in its concerns over the increasing terminal access charges. He says, "the issue of whether rampant stevedore charges should be regulated is a matter for state governments, yet to date, no state government has taken definitive action."

In light of the average per lift revenue charged by stevedores to shipping lines falling 28% over the past decade, Mr. Chambers questioned the reasoning behind the increasing of terminal handling charges imposed by carriers on shippers.

"Have importers or exporters witnessed any of these savings being enjoyed by foreign container shipping lines being passed through in the form of lower charges in Australia? The answer is no," Mr. Chambers claimed, "they can range from over \$400 for a 20ft dry container to over \$800 for a 40ft reefer. And, they have been going up, not down. In contrast, average revenue collected by the stevedores from transport operators for landside services has risen by 266% over the past decade. So, exporters and importers are effectively paying twice for the same stevedore terminal services."

In addition, the ACCC report also stated that the stevedores' average labour productivity fell by 4%, with a deterioration in average truck turnaround times. Mr. Chambers argued that the higher charges with deteriorating service levels was "not a desirable trend."

AUSTRALIA TO OPEN TRAVEL BUBBLE WITH CHINA

rime Minister Scott Morrison has revealed that Australia is considering a future travel bubble arrangement with some Chinese provinces. Despite Australia recording 3 days without any Covid-19 community transmission, Mr. Morrison says the country will "proceed cautiously" regarding a lift on international borders.

Morrison says, "the situation in Europe and the United States is awful. And obviously, that presents great risks for people coming from those parts of the world to Australia."

He indicated that there were ongoing discussions with countries such as Japan, Korea and New Zealand as well as other "low risk" areas across North Asia were also being considered.

He continues, "we continue to hold these discussions with countries like Japan, we have had them before with Korea, the Pacific nations, of course, New Zealand has already been open for travel into Australia without quarantine arrangements. Out of many parts of Asia, particularly in North Asia, places like Taiwan and I would also say parts and provinces of China, Singapore, we are looking at what alternative arrangements could be had to channel visitors through appropriate quarantine arrangements for low risk countries."

National Cabinet is due to discuss more about the international border this Friday, where further assessments, not decisions, will be made.

DUMPING DUTY RELIEF FOR ALUMINIUM EXTRUSION IMPORTERS

ecently the Australian Border Force (ABF) introduced some amendments to the Interim Dumping Duties for aluminium extrusions imported from China.

This comes as slight relief to importers who had been forced to pay as much as 101.9% duty on the inbound cargo value. The following table provides a detailed list of suppliers and exporters with a "Residual Exporter" status.

Cargo imported from residual exporters is subject to 11.5% dumping duty, down from the previous rate level of 29.8%. All other suppliers and exporters cargo is subject to 77.4% dumping duty, which has been reduced from 101.9%.
