

MARKET SUMMARY

- Shipping lines servicing the South-bound East-Asia to Australia trade-lane have made a further GRI announcement to be implemented from 15th August 2023. This is on top of the increase already announced for 1st August which has been successfully implemented by shipping lines with most lines being overbooked and rolling cargo. Rates are expected to hit around USD 1,000 per 40' once the next GRI kicks in.
- Shipping lines have also started making moves to increase their profits through higher terminal and port charges levied on importers and exporters. Tomax

AUSSIES' STRATEGIC ONLINE SHOPPING AMID COST-OF-LIVING PRESSURES

ustralia Post's latest Inside
Australian Online Shopping
Report reveals a shift in Australian
consumer behaviour as cost-of-living
pressures continue to impact spending
habits. With consumer confidence at
low levels, Aussies, especially younger
generations, are becoming "strategic
shoppers," seeking ways to maximise the
value of their money and capitalising on
key sales events.

Gary Starr, Australia Post's Executive General Manager of Parcel, Post, and E-commerce Services, highlights that while more households made online purchases in the fourth quarter compared to the previous year, the effect of costof-living pressures is evident. Online shopping carts are now averaging smaller sizes than before, reflecting cautious and selective spending.

Despite a slow start to 2023 for online retailers, May showed a 5.7 percent increase compared to last year, driven mainly by May sales events. However, overall online purchases have softened, with a 3.1 percent decrease in online spending compared to the previous year.

The report indicates that 9.4 million households, accounting for 82 percent

of the Australian population, made online purchases during the 2023 financial year. The last quarter of the financial year saw an average of 5.5 million households making monthly online purchases, a 3.9

percent increase from the same period last year.

The report also sheds light on the shopping behaviour of young Australians aged 18 to 34, with 85 percent planning to participate in or having already shopped during dedicated sales events. The popularity of customer loyalty programs and bundled services among online shoppers is evident, with one in four consumers opting for online retail subscriptions as part of their cost-saving practices.

Interestingly, regional areas in Australia are experiencing higher year-on-year growth in online shopping compared to metro areas. For example, regional Australia saw a 4.2 percent YoY growth in the last quarter, while metro areas only experienced a 0.7 percent YoY growth.

In response to changing consumer needs, Australia Post continues to invest in new parcel facilities, fleet, and technology. This includes the installation of over 700 parcel lockers and the Australia Post app, allowing customers to conveniently track parcels and manage deliveries and collections using their mobile devices. These efforts are aimed at adapting to the evolving demands of online shoppers in the country.

FIRE EXTINGUISHED ON FREMANTLE HIGHWAY, MORE ELECTRIC VEHICLES REVEALED

he fire on the car-carrier Fremantle
Highway has finally been
extinguished after almost a week,
according to Dutch authorities. Early
reports indicated the vessel carried
only 25 electric vehicles (EVs), but later
investigations unveiled a significantly
higher number of EVs onboard, making
up a larger proportion compared to the
vessel Felicity Ace, which sank in a similar
fire incident last year.

Despite the severity of the fire, the Dutch Ministry of Infrastructure and Waste Management confirmed that there were no hull breaches below the waterline, easing concerns about the vessel sinking at the moment.

Tragically, an Indian crew member lost their life in the fire, while 22 others were taken to the hospital with injuries, some resorting to jumping into the sea from the deck to escape. The fire had engulfed the upper deck, rendering two lifeboats inaccessible.

Authorities are now closely monitoring the stability of the vessel, and ships have been advised to maintain a distance of two miles while approaching.

Fremantle Highway has been towed to a location 10 miles north of the Netherlands' Schiermonnikoog and Ameland islands,

where it will remain until a salvage strategy is devised by the authorities.

In the aftermath, criticisms have emerged in Dutch newspaper Nieuwe Rotterdamsche Courant regarding the outsourcing of helicopter services. Coastguard helicopters, rented from the British-American company Bristow, took twice as long as they should have to arrive at the scene, taking 40 and 49 minutes, in contrast to the coast guard standard of 20 minutes.

This delay is being blamed for the decision by seven of Fremantle Highway's crew to jump overboard, as limited seating meant two helicopters were required for the firefighting team.

The NRC report further reveals that the responsible minister, Mark Harbers, had been warned during the tendering process about the company's inability to keep its promises regarding response time. Despite this, the minister had vouched for the "international company with years of experience" achieving a response time of ten minutes.

PREVENTING INVASIVE SPECIES VIA SEA CONTAINERS: IPPC'S GLOBAL TRADE SAFEGUARD

very year, a staggering 241 million containers traverse the oceans, carrying an array of goods from food and medicines to raw materials and luxury items. Trade plays a vital role in maintaining the global economy and fostering societal growth. However, this crucial activity also brings certain risks. as pests and plants can hitchhike in cargo and containers, causing severe damage when they invade new ecosystems. To address this issue, the International Plant Protection Convention (IPPC) has united industry and government to devise innovative solutions that prevent the transfer of invasive species via sea containers between continents.

The risk of hitchhiker pests travelling through sea containers and imported goods is not to be underestimated, with potential costs being substantial. For instance, an outbreak of khapra beetle in Australia alone is estimated to result in \$15.5 billion of eradication costs and lost markets over a two-decade period.

Given the vast scale of trade, the diverse range of goods, and the myriad of shipping routes connecting continents, stopping invasive species without disrupting international trade or making it economically unfeasible presents a daunting challenge. Nevertheless, the IPPC, in collaboration with regulatory authorities and industry players, is diligently working towards practical and effective solutions that mitigate the global movement of hitchhiker pests.

One promising approach under consideration involves exploring modifications to the structure of sea containers. To investigate this potential solution, the Australian Government has commissioned a research project with Murdoch University's Harry Butler

Institute. The study aims to identify structural design improvements that would reduce spaces within sea containers where hitchhiker pests can hide and contaminants can accumulate.

One critical challenge identified lies in the interfaces around floors and supporting structures of sea containers, where hitchhiker pests are commonly found. These interfaces include cross members, floor joists, forklift pockets, corner fittings, the floor-wall interface, and container corners. The cracks and crevices in the wooden flooring also pose significant concerns, providing ample hiding spots for pests and plant materials.

A notorious example is the khapra beetle, which can survive in cracks and under wooden floorboards for years without food. When favourable conditions arise, such as finding a food source like grain residue, khapra beetles can re-emerge and rapidly multiply, contaminating the container's contents.

Structural modifications to container designs have proven effective in minimising hitchhiker pest risks. Chevron Australia, for instance, invested significantly in sea container redesign, replacing wooden floorboards with steel floors, leading to a notable reduction in hitchhiker pest and contaminant risks.

While addressing pest contamination in the container pathway is crucial, it is equally vital to ensure the smooth movement of sea containers to avoid disruptions in global trade. Delays, even minor ones, can have far-reaching and costly consequences for international supply chains. Therefore, regulatory authorities and industry must work in tandem to devise practical and cost-effective solutions that align with typical container replacement cycles.

Several countries have enforced regulations, and certain global supply chains have embraced best practices to minimise hitchhiker and contaminant risks. Measures include preventing pests and contaminants from entering containers, implementing pesticide or heat treatment for detected organisms, and conducting regular inspections. However, inspections and treatments are not foolproof and can be time-consuming and costly. Consequently, prevention through structural changes in containers is seen as a preferred approach by the parties involved.

Osama El-Lissy, the IPPC Secretary, acknowledges the significance of the public-private partnership in addressing potential pest risks associated with the global movement of sea containers while ensuring trade flows smoothly without unnecessary delays.

AUSTRALIAN RAIL TRACK CORPORATION'S FREIGHT RAIL MAINTENANCE SHUTDOWNS

he Australian Rail Track Corporation (ARTC) has scheduled significant maintenance shutdowns for two key freight rail routes in the upcoming days.

One of the shutdowns will focus on the New South Wales North Coast network, covering areas between Telarah and Acacia Ridge in Queensland. This maintenance work, taking place from Saturday (5 August) to Monday (7 August), is essential to ensure a safe and reliable network. The tasks include rerailing, re-sleepering, track resurfacing, ballasting, and extensive rail replacement efforts, particularly in the section between Taree and Coffs Harbour.

The second shutdown will address maintenance needs on the Hunter Valley Network, spanning from Newcastle to Boggabri, Ulan, and Turrawan. Running from Saturday (5 August) to Tuesday (8 August), the work involves rail and sleeper replacements in critical areas such as Islington, Thornton, Scone, and Werris Creek.

The ARTC plans to conduct over 140 separate maintenance activities throughout the weekend, with an emphasis on completing the tasks safely and efficiently. The maintenance is expected to begin around 0300 on Saturday and conclude around 1500 on Tuesday.
