

MARKET SUMMARY


- Despite conflicting domestic market data and sentiment, including a stronger than expected employment figure and interest rates being left on hold in light of a still strong housing market, international freight rates are continuing to fall. Consumer sentiment, confidence, and spending remain lower globally with many importers and exporters feeling the effects. A protracted downturn is still expected for Australian imports which will cause pain for many businesses in the industry.

TARIFF CONCESSIONS GAZETTE (TC)

Tariff Concession Orders (TCOs) are an Australian Government revenue concession that exists where there are no known Australian manufacturers of goods that are substitutable for imported goods. When a new TCO is made, it is published in the Gazette by the Australian Border Force.

AUSTRALIA'S BIGGEST TARIFF REFORM

he Australian Government is delivering the largest unilateral tariff reform in two decades by setting to 'Free' the rate of duty on around 500 tariff lines. These tariffs have been identified as a nuisance to Australian businesses, imposing unnecessary administrative costs and compliance burdens. Removing these tariffs will save Australian businesses both time and money, boost economic productivity, reduce red tape, help simplify Australia's trade system and ease the cost of living for Australian families by over \$120 million over the next four years.

From 1 July 2024, tariffs will be abolished on a range of imported goods including household necessities such as toothbrushes, tools, fridges, dishwashers and clothing. These tariffs do nothing to protect Australian businesses because they apply to goods that often arrive under a concessional rate. This is an important step in simplifying Australia's trade system and removing compliance burdens for Australian firms. After successive trade agreements, most goods are now imported duty-free. This means that businesses spend time and money proving

their imports are eligible for existing tariff preferences and concessions. Removing tariffs on menstrual and sanitary items will align tariff policy settings with changes made to the GST and put further downward pressure on the price of these goods.

The Government welcomes views from all interested parties to provide feedback on the proposed tariff reform. Submissions can be made on the Treasury website and will close on 1 April 2024. IMPORT OCEAN FREIGHT RATES UPDATE

s of 15th March, there have been some significant rate reductions from North East Asia ports to Australia, following on from some smaller rate reductions on 1st March 2024.

Over the last 3-4 day period, rates from these ports were reviewed several times as lines jockey for as many bookings as they can get, swiftly changing the market.

More savings are expected from 1st April during the traditional "quiet period" with the financial year end fast approaching.

Meanwhile, rates from Europe and the United States have remained stable for the last couple of months, with some minor downwards rate corrections and no rate increases.

There is no change to the current practice of shipping lines avoiding the Red Sea and Suez Canal. All carriers are now transiting north and southbound via Cape of Good Hope and scheduling starting to adjust to the increased transit times.

ADDRESSING ONGOING FREIGHT DISRUPTIONS IN AUSTRALIA

wo transport associations have reiterated concerns over ongoing freight closures across Australia due to weather events, resulting in delays to goods and services.

The Western Roads Federation (WRF) and the Northern Territory Road Transport Association (NTRTA) are urging for an immediate and unified response to Australia's freight system challenges.

Calling for a national meeting to tackle the escalating trans-national freight disruptions exacerbated by floods impacting freight routes in these regions, the associations highlight a lack of progress and ad hoc responses despite two federal parliament inquiries, adding pressure to the transport system.

In addition to these meetings, both associations urge the federal government to adopt an integrated approach and develop a robust National Freight Supply Chain (NFSC) strategy to ensure seamless freight flow and minimise vulnerabilities.

Expressing concerns over persistent freight delays in Western Australia (WA) and the Northern Territory (NT), WRF CEO Cam

Dumesny stresses the need for proactive measures to address infrastructure failures causing disruptions.

NTRTA executive officer Louise Bilato emphasises the urgency for specific actions and accountability measures in the absence of a National Freight Resilience plan, stressing the significant costs to businesses and communities.

Highlighting the critical importance of a coordinated and comprehensive approach to Australia's freight network, Bilato urges a shift from a 'just in time' to a 'just in case' mindset to mitigate rising trans-national freight disruptions.

Both leaders advocate for urgent attention from federal and state governments through a national meeting to address the issue, highlighting the imperative for enhanced collaboration and collective action to safeguard the resilience and stability of Australia's freight network.

Who is your biggest role model? Unfortunately, he has passed away.


If flights were free, where would you go?
